- **Directions to Paulding RYDC 770-443-1166**

Take Hwy 92 North (Dallas Hwy) to Hiram. At Hwy 278, turn left. Go to Hwy 61 and turn right Go to the traffic light and turn left onto Business Hwy 6. Go 1/2 mile or so and turn right onto Legion Road. (There is a Coastal gas station on the right comer.) Go to the stop sign and turn right onto East Memorial Drive. Go about a mile and turn left onto Industrial Boulevard North. Go around the circle and the RYDC is on the right

- **Directions to the Department of Juvenile Justice (770) 489-3022**

Turn right out of the courthouse parking lot onto Hospital Drive. At the traffic light, turn Left onto Fairburn Rd. Turn left onto Spring Street Go approximately half a block and turn left into the Hamilton Place Office Complex. (There is a white fence in front of the complex.) The office is one the left hand side and has a green door with the Department of Juvenile Justice Seal on the front

- **Directions to the Department of Family and Children Services (770) 489-3000**

Turn right out of the courthouse parking lot onto Hospital Drive. At the traffic light, turn Left onto Fairburn Rd.; Get into the far right lane and turn right onto Courtland Rd. Take the first right onto Hospital Way. DFCS will be straight ahead. If information is incorrect or you are still having problems locating resources, please call your caseworker. If you do not have a caseworker, call an Outreach Case Manager at (770) 920-7121.
